# Hope & Wellness Bilingual Mental Health Therapist

### Position Summary:

Liberty House's Hope & Wellness program is seeking licensed bilingual therapists to provide individual, family, and group counseling to children who have been impacted by trauma and/or grief. The role provides a rewarding opportunity to work closely with team members to help children and families thrive. Liberty House provides ongoing training and support.

**Classification: 1 FTE – Exempt.**

### Basic Functions and Responsibilities of the Position:

- Provide triage, assessment, individual, family and group counseling, as well as crisis services for children, birth to age 18 and their families.
- Provide case management and consultation services for children and families as needed to ensure continuity of care.

### Qualifications:

- Graduate degree in Psychology, Social Work, or other mental health related field.
- Licensure in the State of Oregon.
- Three years of clinical practice with children and families, including abuse survivors.
- Fluency in Spanish.

### Employee Hours, Compensation and Benefits:

- Full-time, 40 hours per week or part-time, as negotiated. On-call rotation.
- Salary range: \$24-30/hours, depending upon training and experience.
- Benefit package: health insurance, fully-paid for employee; flexible spending plans; retirement match; eleven paid holidays, paid vacation and sick leave; employee assistance plan; athletic club membership subsidy.

**Benefits not available to Independent Contractors. Salary is based on percentage of payments received for services.**
