FROM THE CEO

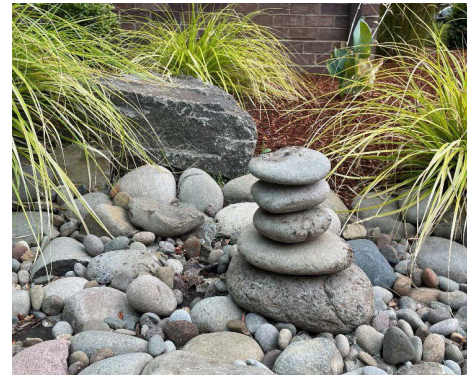
At Liberty House, we change hurt into hope. That means healing the chaos of untreated trauma—serious mental health disorders which can lead to substance abuse, job loss, and homelessness—and helping children take steps on the path to healing. Recently, we saw firsthand what untreated trauma looks like. This camp was set up over a weekend on the Liberty House campus. It took hours and multiple law enforcement officers to clean up, wake up the persons responsible, and connect them to other services to help them. This is just a sample of the devastating effects of untreated trauma.

What is a CAC?

How a Children's Advocacy Center Helps

For children who have experienced physical or sexual assault, or witnessed violence at home, the effects may be profound and wide-ranging. Far too many children in our community have experienced or witnessed these violent acts, often for most of their lives.

Before Liberty House opened its doors in 1999, children often had to recount their experiences of abuse over and over again - to anywhere from three to seven adults - in order to get help. But with a Children's Advocacy Center to rely on, children receive centralized and specialized services in a safe, comfortable, child-friendly environment.



We respond to childhood trauma from every angle: that's why we've added **Hope & Wellness Services** (page 5) and **Prevention Services** (page 6) to our organization. Our therapists at Hope & Wellness provide mental health therapy to children and adults who have experienced trauma, and our Prevention Team educates and equips our community to prevent many kinds of trauma and abuse before it happens.

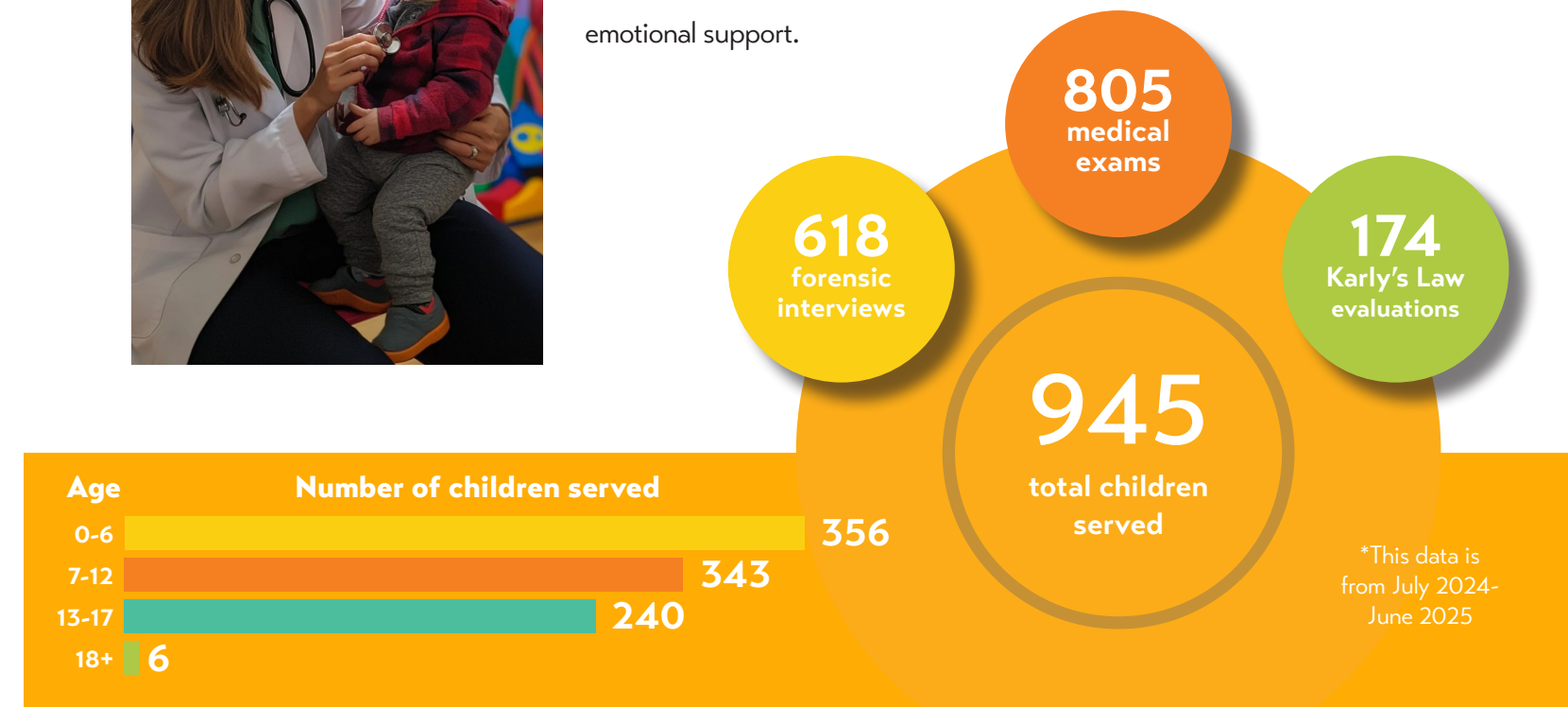
Child Abuse Assessment

As a Children's Advocacy Center, we play a unique and critical role in the community alongside law enforcement, DHS, the District Attorney's office, and other public services.

When parents, teachers, police, or other members of the community have concerns that a child may be the victim of abuse, our community partners can refer the child to Liberty House for an assessment.



From the moment each child arrives, the assessment gradually unfolds at their pace and with their consent. Each assessment is tailored to meet the unique needs of the child and caregiver(s). Children can receive a professionally conducted and recorded forensic interview and a head-to-toe medical exam while accompanying caregiver(s) can meet with a family support specialist to receive resources and emotional support.



Hope & Wellness Services

Hope & Wellness offers trauma-focused therapy for children using a holistic model that includes their caregivers. We also provide services to adults who have experienced trauma in their childhoods. Through these services, children and families receive life-changing help to understand what they have experienced and to find their unique path to healing and a brighter future.



Referrals are generated through the Liberty House clinic and are also open to children assessed at other Children's Advocacy Centers. We also welcome referrals from outside sources including primary caregivers.

The Hope & Wellness Program was established in 2016 in order to better serve our community. The amazing support of many individuals, businesses, and organizations made this service possible.

Prevention Services

The Prevention Department at Liberty House provides training and education in English and Spanish to help our community keep children safe. Our child-safety and online-safety trainings are available in person and virtually for the community as well as businesses, groups, schools, and organizations. We envision a prevention-focused community of partners working together to support children, youth, and families.



Escalating rates of suicide in young people should concern every adult. The internet poses extraordinary safety risks for children and teens, including emotional brutalization and trafficking. To address these risks, Liberty House sought extensive input from parents, teachers, community leaders, and youth to create iRespect&Protect – a community campaign fostering positive self-worth, encouraging safe relationships, and promoting healthy online choices.

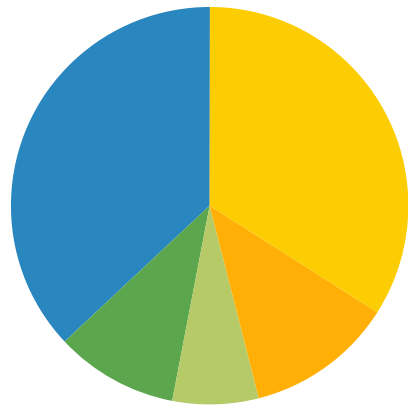

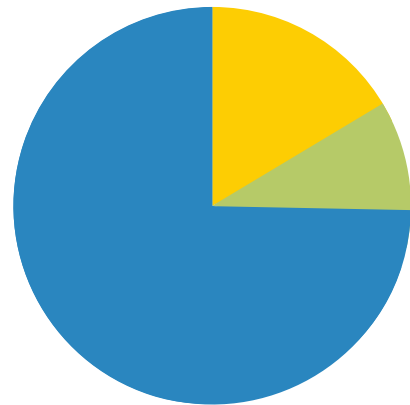

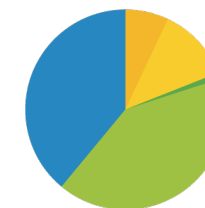

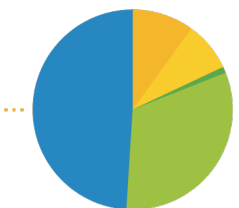

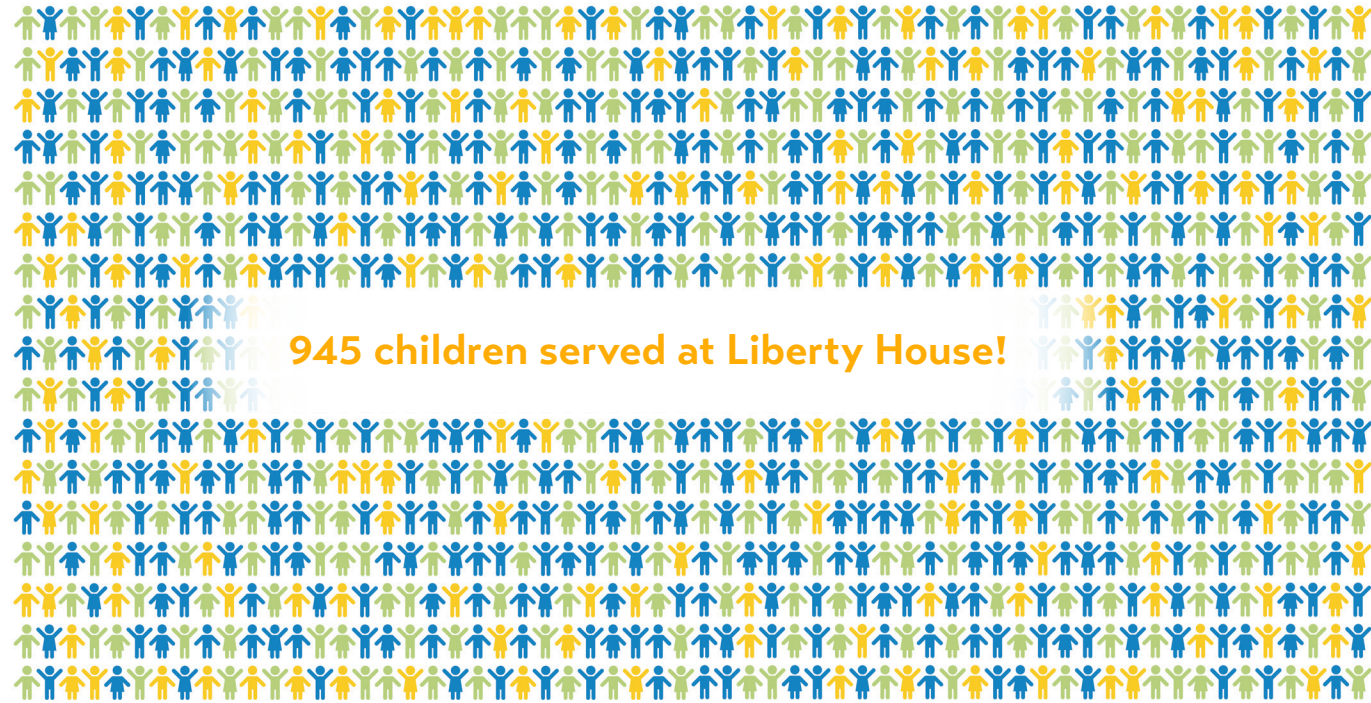
